BAREBONES DETAILS

(Rhys notes)

Res fees \$3000 roughly all in. Could deviate a little now after COVID etc.

COST COMPARISON

- Won't be able to match Elevations \$90 per month BUT we have more to offer, better times, more options, better pools, better overall product, etc.
- City Pass 6 months \$400; \$67 per month

BAM PRICING



- \$70, \$90, \$100, or \$110 per month # of people we need for each of these options
- \$73 (existing BAM pass cost) to \$90 per month?
- June / July / August \$299 up to \$375 with September added?

FINANCIAL UPDATE

- 138 Active Members/Punch Passes
 - Sold 3,823 punches
 - o 1,250 currently unused
- Income
 - \$50,000 in punch pass sales projected \$80,000
- Expenses
 - \$60,000 projected \$84,500
 - Lower than expected due to low coach expenses (Jane coaching more), conservative lane rentals, still need to pay city approx. \$3,500 (no invoice yet)
- Bottom Line
 - About \$85,000 in bank projection around \$50,000

BYLAW UPDATE

Treasurer.

The Treasurer shall have high-level oversight of the fiscal management of BAM and ownership of its long-term financial stability and success. The treasurer is not required to manage the day-to-day finances such as the management of membership fees, refunds, or any associated bank transactions. This responsibility falls to the BAM Manager. The Treasurer shall have a close working relationship with other officers, namely the Board President and Corporate Secretary, as well as the BAM management team. The Treasurer shall take the lead in helping the Board understand how the financial status of BAM will impact its long-term fiscal success and shall be required to have a thorough understanding of BAM's finances, but should not be involved in the day-to-day management of BAM's finances.

The Treasurer may create and/or enforce financial policies, such as who can access funds, who has check-signing authority, how expenses get reimbursed, use of BAM's credit card, and the handling of large financial transactions. It is prudent and wise for the Treasurer to limit access to BAM's funds to prevent allegations of fraud or suspicious spending. The Treasurer and BAM Manager shall work together to produce a quarterly financial report (the "Financial Report"), to be presented to the Board. The Financial Report shall include BAM income and expenses. If there should be a negative cash flow for any of the previous three months prior to a Board meeting, a burn rate shall also be generated. The Financial Report may be requested by the Board President at interim periods. Financial Report information should be kept readily available should there be a request from a BAM member to review the Financial Report.

The Treasurer shall have oversight and a clear understanding of the BAM's taxes, and shall be responsible for overseeing the timely filing of a tax return. The Treasurer and the BAM Manager shall collaborate to submit a budget for Board approval before the beginning of each fiscal year and shall submit to the BAM Board, upon request, all monies, accounts, books, papers, and records pertaining to BAM or annual audit or other purposes. All nonprofit organizations are required to conduct an annual audit. The Treasurer and the BAM Manager shall participate in the BAM annual audit and shall prepare an audit report if one should be required.
